**I. FINAL ACTION STATUS:**

HB 3467 passed the House on April 23, 1998; in the Senate was substituted for SB 2388 and passed on May 1, 1998. Became law without Governor's signature on May 27, 1998. Chapter Law 98-240.

This legislation re-creates the Working Capital Trust Fund without modification. The Working Capital Trust Fund is administered by Department of Highway Safety and Motor Vehicles.
