It is the intent of the Legislature 22 that residential property insurance coverage should not be 23 24 canceled, denied, or nonrenewed solely on the basis of the family day care services at the residence. - (2) DEFINITIONS.--As used in this section, the term:
- (a) "Child care" means the care, protection, and supervision of a child, for a period of less than 24 hours a day on a regular basis, which supplements parental care, enrichment, and health supervision for the child, in accordance with his or her individual needs, and for which a payment, fee, or grant is made for care.
- (b) "Family day care home" means an occupied residence in which child care is regularly provided for children from at least two unrelated families and which receives a payment, fee, or grant for any of the children receiving care, whether or not operated for a profit.
- (3) FAMILY DAY CARE; COVERAGE. -- A residential property insurance policy shall not provide coverage for liability for claims arising out of, or in connection with, the operation of a family day care home, and the insurer shall be under no obligation to defend against lawsuits covering such claims, unless:
 - (a) Specifically covered in a policy; or
- (b) Covered by a rider or endorsement for business coverage attached to a policy.
- PROHIBITED. --An insurer may not deny, cancel, or refuse to renew a policy for residential property insurance solely on the basis that the policyholder or applicant operates a family day care home. In addition to other lawful reasons for refusing to insure, an insurer may deny, cancel, or refuse to renew a policy of a family day care home provider if one or more of the following conditions occur:

22	HOUSE SUMMARY

24	Provides that a residential property insurer is under no obligation to defend any claim arising out of the
25	obligation to defend any claim arising out of the operations of the family day care home unless liability coverage for the family day care home is specifically
26	provided in the policy or by a rider or an endorsement for business coverage. Prohibits cancellation or denial
27	of, or refusal to renew, a policy for the reason that the policyholder or applicant operates a family day care
28	home. Prescribes conditions relating to the operation of a family day care home which will justify denial,
