I. FINAL ACTION STATUS:

House Bill 3689 became law without the Governor's signature on May 28, 1998, and is now cited as **Chapter 98-266**, **Laws of Florida**.

II. SUMMARY:

House Bill 3689 was developed as a result of the Tourism Committee's review of the State Government Function/Activity Review and Prioritization Project as it related to the functions and activities of the Division of Historical Resources (division) of the Department of State. Two statutorily required activities were identified for repeal. The review also indicated the need for clarification of the definition of "historic property" or "historic resource" in s. 267.021, F.S., as it related to folklife. The bill amends s. 267.021, F.S., to provide clarity and repeals ss. 267.16(4) and 267.162, F.S.

Section 267.16(4), F.S., is repealed because it requires the Division of Historical Resource to maintain the Florida Folklife Archives which has been renamed the Florida Folklife Collection and is currently housed within the Florida State Archives which is administered by the Division of Library and Information Services of the Department of State.

The second repealed provision, s. 267.162, F.S., creates the Florida Folklife Grant Program within the division. Prior to the enactment of Ch. 96-418, LOF, which terminated or modified various trust funds within the legislative and executive branches, this section pertained only to the creation of the Florida FolklifeTrust Fund. In this revision of the law, all trust funds in the division were consolidated under the Historical Resources Operating Trust Fund. The consolidation had no effect on the operation of nor funding of the Florida Folklife Program. The change in s. 267.162, F.S., created a grant program that had not existed in the division and was not requested by the program nor division nor is considered by them to be needed for the operation of the Florida Folklife Program.

House Bill 3689 has no fiscal impact.

III. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

The Division of Historical Resources (division) of the Department of State has the statutorily required duty and responsibility for the Florida Folklife Programs as delineated in s. 267.16, F.S. These responsibilities include, but are not limited to, such thing as:

- identify, research, interpret, and present Florida folk arts, artists, performers, folklore, traditions, customs, and cultural heritage and make folk cultural resources and folklife projects available throughout the state;
- prepare publications on folklife to disseminate and sponsor workshops, conferences, festivals, lectures and exhibitions;
- enter into contracts and agreements to carry out its duties and to seek and accept gifts, grants, bequests, loans, and endowments consistent with its duties and responsibilities;
- employ a state folklorist; and
- maintain the Florida Folklife Archives.

The last responsibility cited above is no longer reflective of the responsibilities of the division because of changes that have occurred over the last three years. Originally, the Florida Folklife Archives was established in 1976 as a part of the former Bureau of Florida Folklife Programs located in White Springs, Florida. The Archives was created to serve as a repository for research collected in relation to bureau projects and programs. The bureau was closed and its responsibilities and duties assumed by two other bureaus of the division: Historic Preservation and Historic Museums. In the Fall of 1995 the Archives was relocated from White Springs to the Florida State Archives in Tallahassee. With the reorganization of the Florida Folklife Program, the placement of the information in the Florida State Archives helped to provide better public and staff access and to improve the environmental condition and organization of the materials. The Florida Folklife Archives, renamed the Florida Folklife Collection, is housed within the Florida State Archives which is administered by the Division of Library and Information Services of the Department of State. Although staff from the Division of Library and Information Services and the Division of Historical Resources work closely to maintain and develop the Collection, the responsibility for maintaining the Collection is that of the Florida State Archives under the Division of Library and Information Services.

The Division of Historical Resources receives advice and assistance on ways to achieve the goals of the Florida Folklife Programs from the Florida Folklife Council that is established in s. 267.161, F.S.

The final provision of law relating to Florida Folklife Programs is s. 267.162, F.S., which creates the Florida Folklife Grant Program within the division. Prior to the enactment of Ch. 96-418, LOF, which terminated or modified various trust funds within the legislative

and executive branches, this section pertained only to the creation of the Florida Folklife Trust Fund. In this revision of the law, all trust funds in the division were consolidated under the Historical Resources Operating Trust Fund. The consolidation had no effect on the operation of nor funding of the Florida Folklife Programs. The change in s. 267.162, F.S., created a grant program that had never existed in the division and was not requested by the program nor division nor is considered by them to be needed for the operation of the Florida Folklife Programs.

B. EFFECT OF PROPOSED CHANGES:

The bill repeals the obsolete statutory requirement for the Division of Historical Resources to be responsible for the maintenance of the Florida Folklife Archives. The Archives, now called the Florida Folklife Collection, is housed in the Florida State Archives under the Division of Library and Information Services.

The bill also repeals s. 267.162, F.S., which created a Florida Folklife Grant Program when the section that had been the Florida Folklife Trust Fund had been amended in 1996 to repeal the Trust Fund. This deletes a requirement that created a grant program that had not existed in the division and was not requested by the program nor division nor is considered by them to be needed for the operation of the Florida Folklife Program.

Finally, the bill amends the definition of "historic resource" or "historic property" to clarify that a folklife resource is in fact a historic resource.

Although the statutory requirement for the creation of the Florida Folklife Grant Program in the Division of Historical Resources is repealed, the division has never had a separate grant program for this area. The process for and the level of funding for Florida folklife programs is not altered by the repeal. These are provided in other sections in Chapter 267, F.S., as well as through the appropriations act.

The repeal of s. 267.16(4), F.S., relating to the Florida Folklife Archives, removes the statutory responsibility for the Division of Historical Resources to maintain a separate archive. The responsibility was, in fact, shifted to the State Archives in 1995 which is the responsibility of the Division of Library and Information Services under the Department of State.

VII. AMENDMENTS OR COMMITTEE SUBSTITUTE CHANGES:

The Tourism Committee unanimously passed PCB TU 98-03 on February 3, 1998, for introduction as a Committee Bill. On February 17, 1998, House Bill 3689 was prefiled, on March 3, 1998, it was introduced and on March 5, 1998, it was referred to the Economic Impact Council for ranking. House Bill 3689 was placed on the Economic Impact Council, read a second and third time, and passed by the House on March 24, March 31, and April 1, 1998, respectively. The bill passed the House by a vote of 114 YEAS to 0 NAYS. The Senate referred the bill to the Governmental Reform and Oversight Committee on April 9, 1998. The Committee voted the bill as favorable on April 15, 1998, and reported it out on April 20, 1998. The bill was placed on the Senate Calendar on April 21, 1998, and on Senate Special Order Calendar on April 28, 29, 30, and 31, 1998 and May 1, 1998. On May 1, 1998, HB 3689 was passed by the Senate by a vote of 37 YEAS to 0 NAYS and was ordered enrolled by the House. House Bill 3689 became law without the Governor's signature on May 28, 1998, and is now cited as **Chapter 98-266, Laws of Florida**.
