106.141 Disposition of surplus funds by candidates.--

(4)(a) Except as provided in paragraph (b), any candidate required to dispose of funds pursuant to this section shall, at the option of the candidate, dispose of such funds by any of the following means, or any combination thereof:

1. Return pro rata to each contributor the funds that have not been spent or obligated.

2. Donate the funds that have not been spent or obligated to a charitable organization or organizations that meet the qualifications of s. 501(c)(3) of the Internal

1 Revenue Code.

2 3. Give not more than \$10,000 of the funds that have  
3 not been spent or obligated to the political party of which  
4 such candidate is a member.

5 4. Give the funds that have not been spent or  
6 obligated:

7 a. In the case of a candidate for state office, to the  
8 state, to be deposited in either the Election Campaign  
9 Financing Trust Fund or the General Revenue Fund, as  
10 designated by the candidate; or

11 b. In the case of a candidate for an office of a  
12 political subdivision, to such political subdivision, to be  
13 deposited in the general fund thereof.

14 (b) Any candidate required to dispose of funds  
15 pursuant to this section who has received contributions from  
16 the Election Campaign Financing Trust Fund shall return all  
17 surplus campaign funds to the Election Campaign Financing  
18 Trust Fund.
