Section 1. The introductory paragraph and paragraph (b) of subsection (3) of section 790.001, Florida Statutes, are amended to read:

790.001 Definitions.--<u>As used in this chapter</u> The following words and phrases, when used in this chapter, shall, for the purposes of this chapter, have the meanings respectively ascribed to them in this chapter, except where the context otherwise requires:

- (3)(a) "Concealed weapon" means any dirk, metallic knuckles, slungshot, billie, tear gas gun, chemical weapon or device, or other deadly weapon carried on or about a person in such a manner as to conceal the weapon from the ordinary sight of another person.
- means any weapon of such nature, except a device known as a "self-defense chemical spray." "Self-defense chemical spray" means a device carried solely for purposes of lawful self-defense that is compact in size, designed to be carried on or about the person, and contains not more than two ounces of chemical "Tear gas gun," "chemical weapon," or "device" shall apply to all weapons of such nature except those designed to be carried in a woman's handbag or a man's pants or coat pocket or designed as a pocket pencil or pen and containing not more than one-half ounce of chemical.

Section 2. Section 790.01, Florida Statutes, is amended to read:

790.01 Carrying concealed weapons.--

(1) Except as provided in subsection (4), a person who carries Whoever shall carry a concealed weapon or electric weapon or device on or about his or her person commits shall

be guilty of a misdemeanor of the first degree, punishable as provided in s. 775.082 or s. 775.083.

- (2) A person who carries Whoever shall carry a concealed firearm on or about his or her person commits shall be guilty of a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.
- (3) This section does not apply to a person Nothing in this section shall relate to persons licensed to carry a concealed weapon or a concealed firearm pursuant to the provisions of s.as set forth in ss. 790.053 and 790.06.
- (4) It is not a violation of this section for a person to carry for purposes of lawful self-defense, in a concealed manner:
 - (a) A self-defense chemical spray.
- (b) A nonlethal stun gun or other nonlethal electric weapon or device which does not fire a dart or projectile and is designed solely for defensive purposes.
- Section 3. Section 790.053, Florida Statutes, is amended to read:
 - 790.053 Open carrying of weapons.--
- (1) Except as otherwise provided by law <u>and in</u> <u>subsection (2)</u>, it <u>is shall be</u> unlawful for any person to openly carry on or about his <u>or her</u> person any firearm or electric weapon or device.
- (2) A person may openly carry, for purposes of lawful self-defense:
 - (a) A self-defense chemical spray.
- (b) A nonlethal stun gun or other nonlethal electric weapon or device which does not fire a dart or projectile and is designed solely for defensive purposes; provided, however, that a person may openly carry a stun gun or nonlethal

electric weapon or device designed solely for defensive 1 purposes, which weapon does not fire a dart or projectile. 2 3 (3) Any person violating this section commits shall be guilty of a misdemeanor of the second degree, punishable as 4 5 provided in s. 775.082 or s. 775.083. Section 4. Effective October 1, 1997, and applicable 6 7 to offenses committed on or after that date, section 790.054, Florida Statutes, is created to read: 8 9 790.054 Prohibited use of self-defense weapon or 10 device against law enforcement officer; penalties. -- A person who knowingly and willfully uses a self-defense chemical spray 11 or a nonlethal stun gun or other nonlethal electric weapon or 12 13 device against a law enforcement officer engaged in the performance of his or her duties commits a felony of the third 14 15 degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084. 16 17 Section 5.
