A bill to be entitled

An act relating to drivers' licenses; amending s. 322.21, F.S.; revising language with respect to license fees for the renewal of certain Class D or Class E licenses; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Subsection (1) of section 322.21, Florida Statutes, is amended to read:

322.21 License fees; procedure for handling and collecting fees.--

- (1) Except as otherwise provided herein, the fee for:
- (a) An original or renewal commercial driver's license is \$50, which shall include the fee for driver education provided by s. 233.063; however, if an applicant has completed training and is applying for employment or is currently employed in a public or nonpublic school system that requires the commercial license, the fee shall be the same as for a Class E driver's license. A delinquent fee of \$1 shall be added for a renewal made not more than 12 months after the license expiration date.
- (b) An original Class D or Class E driver's license is \$20, which shall include the fee for driver's education provided by s. 233.063; however, if an applicant has completed training and is applying for employment or is currently employed in a public or nonpublic school system that requires a commercial driver license, the fee shall be the same as for a Class E license.

(c) The renewal or extension of $\frac{a \ Class \ D}{a}$ or $\frac{class \ E}{a}$
driver's license or of a license restricted to motorcycle use
only is \$15, except that a delinquent fee of \$1 shall be added
for a renewal or extension made not more than 12 months after
the license expiration date. The fee provided in this
paragraph shall include the fee for driver's education
provided by s. 233.063.
(d) The renewal or extension of a Class D or Class E
driver's license for an individual who obtains a 4-year
renewal pursuant to s. 322.18(2)(b) is \$40, except that a
delinquent fee of \$1 shall be added for a renewal or extension
made not more than 12 months after the license expiration
date. The fee provided in this paragraph shall include the fee
for driver's education provided by s. 233.063.
(e) The renewal or extension of a Class D or Class E
driver's license for an individual who obtains a 6-year
renewal pursuant to s. 322.18(2)(b), shall be free of charge.
$\frac{(f)}{(d)}$ An original driver's license restricted to
motorcycle use only is \$20, which shall include the fee for
driver's education provided by s. 233.063.
(g) (e) Each endorsement required by s. 322.57 is \$5.
Section 2. This act shall take effect July 1 of the
year in which enacted.

HOUSE SUMMARY
Revises language with respect to license fees for a Class D or Class E driver's license to provide for the renewal for an individual who obtains a 4-year renewal for \$40 with certain fees for delinquent renewal and to provide for the renewal of such a license for individuals entitled to a 6-year renewal free of charge.
