(1) No state agency may expand the existing Orlando Regional Juvenile Detention Center to include property contiguous to the existing center. (2) No state agency may build a new detention center or other commitment facility on property contiguous to the existing center. (3) No state agency may use property contiguous to the existing center for the purpose of operating a detention center or other commitment facility. Section 3. This act shall take effect upon becoming a law. HOUSE SUMMARY Prohibits a state agency from expanding the existing Orlando Regional Juvenile Detention Center to include property contiguous to the existing center, to build a new detention center or other commitment facility on property contiguous to the existing center or to use the property for the purpose of operating a detention center or other commitment facility.
