I. FINAL ACTION STATUS:

House Bill 4097 was passed by the House Committee on Community Affairs on April 6, 1998. The bill was amended by the House on April 24, 1998, and passed as amended by a vote of 117 YEAS and 0 NAYS, and was ordered engrossed. The bill was received by the Senate on April 29, 1998 and was referred to the Senate Committee on Rules and Calendar. It was withdrawn from the Senate Committee on Rules and Calendar on May 1, 1998, and placed on the Senate Local Calendar. The Senate passed 1st ENG/HB 4097 on May, 1, 1998, by a vote of 40 YEAS and 0 NAYS. The bill became chapter 98-500, Laws of Florida.

II. <u>SUMMARY</u>:

The bill dissolves the West Parkland Water Management District.

The bill transfers District obligations and assets to the City of Parkland.

III. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

The West Parkland Water Management District, an independent district, was created by chapter 75-353, Laws of Florida. The purpose of the district is to facilitate the proper development and water control of the land within the District. The governing board of the District consists of five supervisors. The District's powers include, but are not limited to, the authority to: acquire property, contract, sue, adopt water management and control plans, regulate supply and water level, borrow money and issue bonds and other indebtedness, construct bridges, collect fees and rates, and assess and collect ad valorem taxes.

Section 189.4042(2), Florida Statutes, provides that a merger or dissolution of an independent special district created by special act of the Legislature may only be effectuated by the Legislature unless otherwise provided by general law.

B. EFFECT OF PROPOSED CHANGES:

The bill dissolves the West Parkland Water Management District.

The bill transfers District assets and obligations to the City of Parkland.

Although the District was created, it was never organized because there was no need for it. A neighbor allowed residents in the Ranches to drain onto his property.

The bill abolishes an antiquated District and can be abolished without loss of any public service. Water management practices in the city are covered by a number of special districts and by the City of Parkland through special assessments.
