I. SUMMARY:

This bill excludes a tract of land from the boundaries of the San Carlos Park Fire Protection and Rescue Service District (District). This exclusion encompasses approximately 62.35 acres from the District.

This bill increases the maximum ad valorem tax millage that may be levied by the District from \$2.00 to \$3.75 per \$1,000 of net taxable assessed valuation, upon voter approval.

The District will receive an estimated \$10,000.00 in additional revenues, if approved.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

The San Carlos Park Fire Protection and Rescue District (District), an independent special district, was established by a special act of the Legislature in 1976. The District originally served an area of approximately 26 square miles. Chapter 89-494, Laws of Florida, expanded the District's boundaries to include approximately 30 acres that had been contiguous to the southeast boundary of the district. The boundaries were again expanded by chapter 94-457, Laws of Florida, to annex an additional 23 square miles lying to the east of the District.

Chapter 94-457, Laws of Florida, created two enclave areas by excluding the site of the university foundation as well as the site for Florida's most recent public university, Florida Gulf Coast University. Chapter 95-463 again expanded the boundaries of the District.

When the District was established in 1976, it was granted the authority to levy ad valorem taxes up to \$1.00 per 1,000 of net taxable assessed value. Chapter 80-521, Laws of Florida, increased the maximum amount of ad valorem taxes that the District could levy to \$2.00.

The District now serves a community of approximately 20,000 residents within a 50 square mile area. Approximately 1,618 calls are responded to annually with an average response time of one minute. This represents a 6% increase in the number of annual calls since 1995. The District employs 31 people as well as utilizing volunteer personnel. One aerial; two rescue mini-pumpers; 2 brush units; one mechanical vehicle; one inspector's vehicle; and four staff vehicles are owned and maintained by the District.

The district is in the process of acquiring a piece of property near the Florida Gulf Coast University in order to serve the University population. Future services include equipment and training necessary to provide advanced life support services (ALS) to the area.

B. EFFECT OF PROPOSED CHANGES:

This bill amends current law to *exclude* a 62.35 acre tract of land from the San Carlos Park Fire Protection and Rescue Service District.

This bill also amends current law to increase the maximum ad valorem tax millage that may be imposed by the District to 3.75 mills, upon voter approval.

E. SECTION-BY-SECTION ANALYSIS:

<u>Section 1</u> -- Amends current law to exclude approximately 62.35 acres from the San Carlos Park Fire Protection and Rescue Services District.

<u>Section 2</u> -- Amends, subsection (1) of section 5 of chapter 76-411, Laws of Florida, as amended, relating to the power of the Board to levy millage tax against taxable real estate within the District.

<u>Section 3</u> -- Provides for a referendum of all qualified electors within the District to be called by the Board of Commissioners of the District and to be held in conjunction with the next primary or general election, in accordance with current election law. Section 2 of this bill will take effect only upon its approval by a majority vote of the qualified district electors.

<u>Section 4</u> -- Provides that this act shall take effect upon becoming law.

IV. **COMMENTS**:

This bill will exclude 62.35 acres of land from the San Carlos Park Fire Protection and Rescue Service District. This 62.35 acres is currently in both the San Carlos Park District and the Estero Fire District.

The Fire Chief's Assistant asserts that these acres were improperly annexed into the San Carlos Park District by Chapter 95-463, Laws of Florida, and that the Estero Fire District wishes to continue to service that area.

This will be the second increase in the millage revenues that the Legislature has authorized for this district since its creation 20 years ago.

The Fire Chief's Assistant commented that this increase in the millage cap is being sought to provide more manpower in order fulfill its contractual obligation to service Florida Gulf Coast University. The District would also like to provide advanced life support service to the area. This entails procurement of equipment, training for personnel, and an increase in salary for those providing the advanced life support services.

This bill is anticipated to generate an additional revenue of \$10,000.00 for the 1997-98 fiscal year. The cost of adding this issue to the next general or primary election is \$2,000.00.

V. <u>AMENDMENTS OR COMMITTEE SUBSTITUTE CHANGES</u>:

The sponsor has agreed to technical amendments to the bill. Section 2 of the bill has been amended to strike sections which already are provided for in chapter 76-411, Laws of Florida, as amended, while maintaining the provision for increasing the millage cap.
