or between nongovernmental entities, which contracts are in effect prior to the effective date of annexation. Section 4. Notwithstanding the provisions of s. 335.0415, Florida Statutes, all public roads and the public rights of way associated therewith, lying within the limits of the lands subject to annexation herein, as described in section 1, are transferred from Broward County jurisdiction to the jurisdiction of the annexing municipality. All rights, title, interests, and responsibilities for any transferred roads, including, but not limited to, the operation, maintenance, planning, design, and construction of said roads, and the rights of way associated therewith, shall transfer from Broward County jurisdiction to the jurisdiction of the annexing municipality upon the effective date of this act. Section 5. This act shall take effect October 1 of the year in which enacted.
