All rights, title, interests, and responsibilities for any transferred roads, including, but not limited to, the operation, maintenance, planning, design, and construction of said roads, and the rights of way associated therewith shall transfer from Broward County jurisdiction to the jurisdiction of the annexing municipality upon the effective date of this act. Section 5. This act shall take effect October 1 of the year in which enacted.
