A bill to be entitled 1 2 An act relating to school readiness; creating 3 s. 411.09, F.S.; creating the healthy opportunity for school readiness voucher 4 5 program; providing legislative findings and intent; providing for operation by the Florida 6 7 Partnership for Children First, Inc.; providing 8 eligibility requirements and program components and funding; providing an effective date. 9 10 11 WHEREAS, the bridge to opportunity for every child must 12 be anchored in a healthy body and a healthy mind and must lead 13 to the child's readiness to learn in school, and 14 WHEREAS, it is widely acknowledged that entering school 15 ready to learn is crucial to a child's success both in school 16 and in life, and WHEREAS, the state's system of public education could 17 better perform its mission of educating its K-12 students if 18 19 more students enter school healthy and ready to learn, and 20 WHEREAS, as emphasized by the Governor, the President 21 of the Senate, and the Speaker of the House of 22 Representatives, a child's health in both body and mind is essential to the child's ability to learn, and 23 24 WHEREAS, we can make great strides to improve school readiness by addressing child care, child health, and school 25 26 readiness education in one single, accountable continuum, NOW, 27 THEREFORE, 28 29 Be It Enacted by the Legislature of the State of Florida: 30

 Section 1. Section 411.09, Florida Statutes, is created to read:

411.09 Healthy opportunity for school readiness voucher program.--

- (1) LEGISLATIVE FINDINGS.--
- (a) Current standards for measuring school readiness are nonuniform and highly subjective. Measurements by these standards indicate that approximately 36,000 or 20 percent of Florida children were measured as not ready for school when they entered kindergarten in the 1996-1997 school year.
- (b) The Florida Partnership for Children First, Inc., is assigned the responsibility under s. 411.01 of providing reliable school readiness instruments, which instruments shall be administered under the oversight of the Children First Coalitions.
- (c) Under the current measurement system, the statewide distribution of children measured as not ready for school in kindergarten ranges from a high of 60 percent in Monroe County to a low of 4 percent in Washington County. Most districts, however, are in the 10 to 25 percent range of children measured as not ready for school in kindergarten.
- (d) Numerous credible studies have demonstrated the importance of school readiness to a child's success in school, and the cost savings, particularly in terms of less dependence on specialized services and greater lifelong opportunity, achieved in enlarging the percentage of children who attain school readiness before they enter school.
- (e) A recent study of Florida's independent schools indicates the possibility of the availability of roughly 3,000 to 5,000 kindergarten seats statewide, a very small number in

proportion to the number of Florida children measured as not ready for school.

- (f) The public K-12 school system could better perform its mission of K-12 education if there were a higher percentage of children entering the public K-12 school system who were measured as ready for school.
- (2) LEGISLATIVE INTENT.--Subject to the requirements of this section and the availability of seats, it is the intent of the Legislature to provide a program of enhancement of healthy opportunity by increasing school readiness to the maximum extent feasible before a child enters the public K-12 school system.
- (3) HEALTHY OPPORTUNITY PROGRAM; ELIGIBILITY OF
 CHILD.—The healthy opportunity for school readiness voucher
 program is established and shall be available on a first-come,
 first-served basis to children who are measured no later than
 February of the year in which they will enter kindergarten as
 not ready for school. Participation shall be entirely at the
 option of the parent or guardian.
- (4) HEALTHY OPPORTUNITY VOUCHERS.--For the purpose of assisting children who are measured as not ready for school to attain success in school by enhancing their opportunity for school readiness:
- (a) The Florida Partnership for Children First, Inc., shall operate the healthy opportunity for school readiness voucher program with the following minimum components:
- 1. Each Children First Coalition, as part of the children first plan, shall establish and maintain private kindergarten program choice information to provide information and assistance to parents or guardians of eligible children who wish to enhance their child's opportunity for school

readiness by obtaining a voucher to pay for attendance in a private kindergarten of the parent's choice that has an available seat and agrees to accept the child. Private kindergartens wishing to participate in the program shall submit information requested by the Children First Coalition for purposes of informed parental choice, shall agree to the goal of the child attaining school readiness, and shall agree to administer the school readiness screening instruments.

- 2. All selections and all enrollment and transportation arrangements shall be the parents' or guardians' responsibility, but the Children First Coalition shall provide full information, including information regarding teacher credentials, and adequate guidance and assistance to enable the parents or guardians to make a fully informed choice and easily facilitated arrangements.
- 3. Upon authorization of the parent or guardian, payment by the fiscal agent of the Children First Coalition shall be made by voucher in the name of the parent or guardian and shall be sent to the private kindergarten selected, where the parent or guardian may endorse the payment to secure the child's seat. Such payment shall be made in nine to twelve equal monthly payments, per agreement, in an amount not to exceed the total cost of tuition or \$3,500, whichever is less.
- 4. A private kindergarten participating in the program shall comply with s. 623.02 and all other applicable law, including nondiscrimination in admission policy.
- 5. The Children First Coalition shall provide for followup measurement of the children who participate in the program, to measure their school readiness after a year of attending private kindergarten and prior to entering first grade. The coalition shall annually report to the Children

First Partnership, using objective data, the differences in school readiness, if any, between comparable groups of children based on whether or not they attended a private kindergarten with tuition paid by a healthy opportunity for school readiness voucher. (b) The vouchers shall be funded from funds appropriated through the FEFP for a school district's kindergarten program and shall be made available on a first-come, first-served basis. Section 2. This act shall take effect July 1, 1999. ********** HOUSE SUMMARY Creates the healthy opportunity for school readiness voucher program to be operated by the Florida Partnership for Children First, Inc. Provides eligibility for children who are measured no later than February of the year in which they will enter kindergarten as not ready for school. Provides requirements for participation by private kindergartens. Provides for payment by voucher and specifies funding for the program.
