This act may be cited as the "Florida 14 Residents' Tax Relief Act of 1998." 15 Section 2. (1) No tax levied under the provisions of chapter 212, Florida Statutes, shall be collected on sales of 16 17 clothing having a taxable value of \$50 or less during the period from 12:01 a.m., August 15, 1998, through midnight, 18 19 August 21, 1998. 20 (2) As used in this section, "clothing" means any article of wearing apparel, including footwear, intended to be 21 worn on or about the human body. For purposes of this section, 22 "clothing" does not include watches, watchbands, jewelry, 23 handbags, handkerchiefs, umbrellas, scarves, ties, headbands, 24

(3) This section does not apply to sales within a theme park or entertainment complex, as defined in s.

509.013(9), Florida Statutes, or within a public lodging establishment, as defined in s. 509.013(4), Florida Statutes.

(4) The provisions of chapter 120, Florida Statutes, to the contrary notwithstanding the Department of Revenue is

1	authorized to adopt rules to carry out the provisions of this
2	section.
3	Section 3. The sum of \$200,000 is appropriated from
4	the General Revenue Fund to the Department of Revenue for the
5	purpose of administering this act.
6	Section 4. This act shall take effect upon becoming a
7	law.
