I. FINAL ACTION STATUS:

The bill was filed March 26, 1998 and introduced March 31, 1998. The bill was referred to the House Committee on Community Affairs and voted favorably by the committee on April 21, 1998. The bill was placed on the House Local Calendar April 24, 1998 and approved by the House 120 YEAS 0 NAYS on April 24, 1998. The bill was received by the Senate in Messages April 24, 1998 and referred to the Committee on Rules and Calendar April 28, 1998. The bill was withdrawn from the committee, placed on the Senate Local Calendar May 1, 1998 and approved by the Senate 40 YEAS 0 NAYS. The bill became law without the Governor's signature and is chapter 98-521, Laws of Florida.

II. SUMMARY:

This bill creates the South Broward Utility Advisory Board. The bill provides for memberships, qualifications, terms, responsibilities, and powers of the board. The bill provides an appropriation for the board. The bill provides a limitation of the powers of the board. The bill provides for adoption of procedures and regulations.

III. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

South Broward Utility, Inc.:

South Broward Utility, Inc. was a privately owned water and sewer utility company. This company was purchased by the City of Sunrise, in late 1997.

B. EFFECT OF PROPOSED CHANGES:

This bill creates the South Broward Utility Advisory Board consisting of 7 members with 2 year terms, as follows:

- 2 members appointed by the City of Sunrise;
- 2 members appointed by the Town of Davie;
- 1 members appointed by the City of Pembrook Pines; and
- 2 members appointed by the Broward County Commission.

Each appointed member must be a water and sewer user within the service area of the former South Broward Utility.

The advisory board is responsible for advising the City of Sunrise regarding proposed water and sewer rate changes for the service area formerly controlled by the South Broward Utility. In the event of a proposed rate change, the advisory board can require the City of Sunrise to hire a rate consultant to advise the city.

Within 30 days after the City issues a notice of rate change, the advisory board must present a report of its findings regarding the rate change. A report submitted within the 30-day period must be considered by the City before rates can be altered or changed within the former South Broward Utility service area.

The City of Sunrise must appropriate not more than \$25,000 annually for a rate consultant for the advisory board.

The advisory board has no legal standing to bring any legal action.

The City of Sunrise must adopt, by ordinance, procedures and regulations which are not in conflict with this act that are necessary for the continued operation of the advisory board.

This bill requires the City of Sunrise to appoint 2 members to the advisory board; adopt ordinances to provide procedures and regulations for the board; appropriate not more than \$25,000 per year to hire a rate consultant; and consider the advisory board's timely filed report prior to altering or changing rates in the former South Broward Utility service area.

This bill requires the Town of Davie to appoint 2 members to the advisory board.

This bill requires the City of Pembroke Pines to appoint 1 member to the advisory board.

This bill requires the Broward County Commission to appoint 2 members to the advisory board.

This bill requires the 7 member advisory board to prepare and present a report of its findings regarding rate alterations or changes in the former South Broward Utility service area within 30 days after a notice of rate change has been issued.

E. SECTION-BY-SECTION RESEARCH:

Section 1: Creates the South Broward Utility Advisory Board, an advisory board of the City of Sunrise. The board will consist of 7 members, as follows:

- 2 members appointed by the City of Sunrise;
- 2 members appointed by the Town of Davie;
- 1 members appointed by the City of Pembrook Pines; and
- 2 members appointed by the Broward County Commission.

Each appointed member must be a water and sewer user within the service area of the former South Broward Utility.

Each member will serve for a 2-year term, except that all appointments and retention of board members is at the sole discretion of the appointing authorities.

The advisory board's responsibilities are to review and advise the City of Sunrise regarding any proposed utility rate alterations or changes with the former South Broward Utility service area. The advisory board can require the City of Sunrise to hire a rate consultant to advise the city on proposed rate alterations or changes. The City must appropriate not more than \$25,000 annually for a rate consultant for the advisory board.

Within 30 days following a notice of rate change the advisory board must present to the City of Sunrise a report of its findings regarding the proposed change. The City must consider the report before rates may be altered or changed within the former South Broward Utility service area.

The City must adopt, by ordinance, the procedures and regulations which are not in conflict with this act which are necessary for the continued operation of the advisory board.

Section 2: Provides that this act takes effect upon becoming law.
