(b) Beginning in fiscal year 1999-2000, and annually thereafter, each water management district shall incorporate the applicable program priorities in the development of its budget.

(c) As part of its review of water management district budgets pursuant to this section, the Executive Office of the Governor shall determine whether each district's budget is consistent with the applicable program priorities. In determining whether a district's budget is consistent with the applicable program priorities, the Executive Office of the Governor shall take into consideration comments on or objections to the proposed budget by the public and members of the Legislature, including comments and objections submitted by the chairs of the House and Senate appropriations committees pursuant to paragraph (5)(d), and the district's need to address natural disasters, other unforeseen circumstances, or issues of substantial concern to the citizens of the region. By September 15, 1999, and annually thereafter, the Executive Office of the Governor shall notify in writing the President of the Senate, the Speaker of the House of Representatives, and the chairs of the substantive and fiscal committees having jurisdiction over water management district activities as to all determinations made pursuant to this subsection.

(d) Based on the authority granted the Executive
Office of the Governor to approve or disapprove, in whole or
in part, the budget of each water management district in
paragraph (5)(a), and in accordance with the specific
processes outlined in paragraph (5)(b), the Executive Office
of the Governor shall disapprove those portions of a water
management district's budget that it determines, under

paragraph (c), are inconsistent with the applicable program priorities. Section 2. This act shall take effect October 31, 1998.
