I. FINAL ACTION STATUS:

HB 4579 passed the House on April 23, 1998; in the Senate was substituted for SB 2410 and passed on May 1, 1998. Became law without Governor's signature on May 30, 1998. Chapter Law 98-346.

II. SUMMARY:

This legislation re-creates the Florida Agricultural Exposition Trust Fund without modification. The Florida Agricultural Exposition Trust Fund is administered by the Department of Corrections.

III. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 570.071, F.S., creates trust fund and specifies revenue sources

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The Department of Agriculture and Consumer Services and the Department of Corrections are authorized to construct and equip an agricultural exposition center in Palm Beach County. This center, known as "Florida Agricultural Exposition", is to be used as a place to sell Florida Agricultural products; to attract and inform buyers; to conduct short courses and conferences; and to train prisoners of the correctional institutions of the state in agricultural labor and management. The Legislature appropriated \$107,358 for the 1998-1999 fiscal year to the Department of Corrections for this trust fund.
