I. FINAL ACTION STATUS:

HB 4587 passed the House on April 23, 1998; in the Senate was substituted for SB 2422 and passed on May 1, 1998. Became law without Governor's signature on May 30, 1998. Chapter Law 98-350.

II. SUMMARY:

This legislation re-creates the Capital Collateral Representative Trust Fund without modification. The Capital Collateral Representative Trust Fund is administered by the Justice Administration Commission.

III. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 27.702, F.S., creates the trust fund and provides for deposit of federal funds contributed to the Capital Collateral Representative for legal representation of death row inmates in the federal court pursuant to the Criminal Justice Act (18 USC 3006A).

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The receipts of the Capital Collateral Representative Trust Fund are expended on litigation activities as approved by the Legislature. The 1998-1999 fiscal year appropriation is \$145,017.

3. MAJOR SOURCES OF REVENUE FOR THE FUND: The primary source of revenue for the Capital Collateral Representative Trust Fund is federal funds as provided by Congress pursuant to the Criminal Justice Act for reimbursement for representation of capital defendants in the federal court. B. EFFECT OF PROPOSED CHANGES: This bill re-creates the trust fund without modification. C. STATUTE(S) AFFECTED: N/A IV. FISCAL RESEARCH & ECONOMIC IMPACT STATEMENT: This legislation has no fiscal impact on state agencies or state funds, on local governments as a whole or on the private sector.
