# I. FINAL ACTION STATUS:

HB 4627 passed the House on April 23, 1998; in the Senate was substituted for SB 2392 and passed on May 1, 1998. Became law without Governor's signature on May 30, 1998. Chapter Law 98-370.

# II. SUMMARY:

This legislation re-creates the Crimes Compensation Trust Fund without modification. The Crimes Compensation Trust Fund is administered by the Department of Legal Affairs.

#### III. SUBSTANTIVE RESEARCH:

#### A. PRESENT SITUATION:

# 1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 960.21, F.S., creates trust fund and provides its purpose. Section 960.20, F.S., provides for assessment, collection, and deposit of the fee.

#### 2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The receipts of the Crimes Compensation Trust Fund are expended for operating costs incurred by the department in executing the "Florida Crimes Compensation Act," service to victims suffering property loss, service to victims of sexual assault, and victim service programs provided at the appellate and trial court levels. The 1998-1999 fiscal year appropriation is \$44,070,488.

#### 3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The primary source of revenue is a \$50 fee assessable on a person who pleads guilty or nolo contendere to, or is convicted of or adjudicated delinquent for, any felony, misdemeanor, or criminal traffic offense, or violation of any municipal or
