I. FINAL ACTION STATUS:

HB 4637 passed the House on April 23, 1998; in the Senate was substituted for SB 2402 and passed on May 1, 1998. Became law without Governor's signature on May 30, 1998. Chapter Law 98-375.

II. SUMMARY:

This legislation re-creates the Motor Vehicle Warranty Trust Fund without modification. The Motor Vehicle Warranty Trust Fund is administered by the Department of Legal Affairs.

III. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 681.117, F.S., provides for collection and distribution of the fee.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The receipts of the Motor Vehicle Warranty Trust Fund are expended for the administration and coordination of the Florida New Motor Vehicle Arbitration Board. The 1998-1999 fiscal year appropriation is \$1,993,686.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The primary source of revenue is a \$2 charge on the sale or lease of motor vehicles which is collected and enforced by the Department of Revenue. One-fourth of the money received by the Department of Legal Affairs is transferred to the Division of Consumer Service of the Department of Agriculture and Consumer Services to carry out the provisions of lemon law dispute settlement (s. 681.108 and 681.109, F.S.).
