The 25 26 trust fund is exempt from the service charges imposed by s. 27 215.20. 28 (2) Notwithstanding the provisions of s. 216.301 and pursuant to s. 216.351, any balance in the trust fund at the 29 end of any fiscal year shall remain in the trust fund at the 30
