Sections 12, 13, 14, and 15 of chapter 21 63-1558, Laws of Florida, as amended by chapter 79-501, Laws 22 of Florida, are hereby repealed, and remaining sections are 23 renumbered accordingly. Section 2. Section 12 of chapter 63-1558, Laws of 24 25 Florida, as amended by chapter 79-501, Laws of Florida, is 26 created to read: 27 Section 12. The Fire Control Board of the Matlacha and 28 Pine Island Fire Control District shall have the right, power, 29 and authority to employ such personnel as deemed necessary for 30 the proper function and operation of the Fire Department for 31 the establishment and maintenance of emergency medical and 1

Section 3. Section 6 of chapter 63-1558, Laws of 6 7 Florida, is amended to read: 8 Section 6.
