Be It Enacted by the Legislature of the State of Florida:

Section 1. Sections 1, 2, 3, 4, 5, and 6 of chapter 72-666, Laws of Florida, as amended by section 1 of chapter 75-495, Laws of Florida; section 1 of chapter 78-592, Laws of Florida; section 1 of chapter 82-370, Laws of Florida; and section 1 of chapter 85-491, Laws of Florida, are amended to read:

22 Section 1. Council created. -- There is hereby chartered 23 and created a voluntary nonprofit non-profit organization to be known as the "Pinellas Police Standards Council,", 24 25 hereinafter called "the council," to conduct continuous 26 planning and studies for the purpose of making recommendations 27 to the Pinellas County legislative delegation concerning 28 countywide county-wide police standards covering every aspect 29 of law enforcement.

The council shall not have power to compel any action 31 by any law enforcement agency or municipality but shall seek

to promote a total cooperative effort between itself and the various municipalities to upgrade and preserve responsible local law enforcement agencies and to assist the Legislature in its efforts toward that end.

Section 2. Membership of the council; terms of office; vacancies.—The council shall be <u>composed</u> comprised of members to be selected as follows:

- enforcement agency employing law enforcement officers as defined in chapter 943, Florida Statutes, having its headquarters municipality in Pinellas County having its own police department, to be the Chief of Police or his designee.
 - (b) The Sheriff of Pinellas County or his designee.
- (c) The State Attorney or <u>his designee</u> one (1) member from the State Attorney's staff who shall be a prosecuting attorney or investigator to be appointed by the State Attorney.
- (d) The director of the <u>Southeastern Public Safety</u> <u>Institute at St. Petersburg Junior College</u> <u>Pinellas Police</u> <u>Academy</u> or his designee.

(e)

- (1) All members of the council who are police officers should be of the rank of sergeant or above.
- (2) Terms of office shall be for one (1) year and should run from June 1 to June 1 of each year.
- (3) Vacancies shall be filled in the same manner as the selection of members.

Section 3. Officers; meetings; quorum.--

(a) The council shall elect one of its members as chairman, who shall serve from June 1 through May 31 of the

<u>following year</u>. Other offices, if any, shall be created by the council.

- (b) The council shall meet at least once each month, at such other times as the council may determine, and at any other time at the call of the chairman. It shall adopt rules for the transaction of business and keep records a record of its transactions, resolutions, findings, determinations, and recommendations, which records shall be public records a public record.
- (c) At all meetings of the council, there shall be eleven (11) members required for a quorum shall consist of a majority of the membership. No Official business of the council may not shall be transacted unless a quorum is present.

Section 4. Powers and duties.—In the performance of its duties and the execution of its functions under this act, the council shall have the following powers:

- (a) To maintain an office at such place or places within Pinellas County as it designates may designate.
 - (b) To hold public hearings and sponsor public forums.
- (c) To <u>enter into agreements with, accept and expend</u>

 federal funds and grants from, and accept and use services

 from:
 - (1) The Federal Government and its agencies.
 - (2) The state government and it agencies.
- (3) The county government <u>and its agencies</u>, <u>including</u> the <u>Pinellas County Police Academy</u>.
 - (4) The several municipalities in Pinellas County.
 - (5) Private or civic sources.

- (d) To study and conduct investigations into the financial and other operations of each municipal police department.
- (e) To study ways to promote cooperation between all law enforcement agencies in securing efficient and effective law enforcement.
- (f) To recommend cooperative policies for the coordination of law enforcement within Pinellas County and all its municipalities.
- To make recommendations that which would lead to the elimination of duplication of effort, if any.
- (h) To hire an executive director to conduct the business of the council at its direction and supervise such other employees as are authorized by the council to perform necessary tasks Make recommendations concerning a civil service system for those departments which do not presently have such a system.
- (i) To make recommendations concerning minimum standards for in connection with employment, compensation, 20 (including retirement plans) and training of law enforcement police officers and law enforcement support personnel, as well as departmental facilities, equipment, and over-all manpower needs. Consideration should be given to a uniform county-wide minimum salary scale designed to discourage personnel turnover.
 - (j) To make recommendations concerning law enforcement in general which would enhance the quality of such law enforcement.
 - (k) (1) To The Council shall provide for a centralized screening and information center on prospective law enforcement officers in Pinellas County, to be known as the

Public Safety Applicant Screening Service (PSASS). The Pinellas Police Academy shall be the depository for the centralized information center.

- (1) The council shall provide standardized forms, screening, testing, physical exams, and other necessary background research concerning of prospective applicants and shall provide information from a the centralized candidate pool to law enforcement agencies in Pinellas County. Each law enforcement agency may shall use the forms provided by the council, and shall provide to the council for use by PSASS in the Center copies of applications and results of any screening and background investigation performed by the agency. When processing applicants, each law enforcement agency may shall request a report from PSASS the Center regarding any prospective employee of that agency. Applicant information from PSASS the Center shall only be released only upon the request of a law enforcement agency and the applicant.
- the Board of County Commissioners for their approval. Funding for The provisions of this section shall be funded by a \$2 court cost two dollar assessment on all uncontested payable offenses, to be assessed by the circuit and county courts in Pinellas County on all contested and uncontested traffic cases, criminal and civil, excluding parking fines, bicycle violations, and pedestrian violations that which are payable offenses. Additional funding may be secured by the council by assessing the law enforcement police agencies a fee for the cost of screening the applicants.
- (3) The <u>council may establish reasonable fees to be</u>

 paid by applicants to offset a portion of the screening costs

29 30 director for the Centralized Information Center under the control of the Pinellas Police Standards Council.

(1) To provide similar applicant testing, screening, and information services, as outlined in this section, for the state and its agencies, Pinellas County, the several municipalities within Pinellas County, or entities that provide public-safety-related services through contract with any of the foregoing, for prospective candidates for law enforcement, law enforcement support, corrections, or public safety positions, including, but not limited to, law enforcement officer, corrections officer, public safety answering point call taker, dispatcher, communications operator, crime scene technician, firefighter, emergency medical technician, or paramedic. The council may enter into agreements necessary to carry out this work, with the costs of such screening, including a reasonable allowance for overhead, being paid by the agency receiving the service. Such agreements may provide for reasonable fees to be paid by applicants to offset a portion of the screening costs.

Section 5. Compensation and expenses.—Members of the council shall receive no compensation for their services, but if funds are made available they shall be entitled to reimbursement for necessary travel and other expenses incurred in the work of the council. The several municipalities of the county are authorized to provide personnel, facilities, and funds to assist in the work of the council.

Section 6. Adoption of recommendations and procedure after adoption.—Recommendations of from the council or its members shall be adopted by a majority vote of the members present. Following adoption of a recommendation, said recommendation shall be reduced to writing and sent to the
