Section 236.08106, Florida Statutes, is 18 19 created to read: 20 236.08106 Excellent Teaching Program. --(1) The Legislature recognizes that teachers play a 21 22 critical role in preparing students to achieve the high levels 23 of academic performance expected by the Sunshine State 24 Standards. The Legislature further recognizes the importance of identifying and rewarding teaching excellence and of 25 26 encouraging good teachers to become excellent teachers. The 27 Legislature finds that the National Board of Professional Teaching Standards (NBPTS) has established high and rigorous 28 standards for accomplished teaching and has developed a 29 30 national voluntary system for assessing and certifying teachers who demonstrate teaching excellence by meeting those 31 1 9:24 AM 04/24/98 h0755.ed06.bc

standards. It is therefore the Legislature's intent to provide 1 2 incentives for teachers to seek NBPTS certification and to 3 reward teachers who demonstrate teaching excellence by 4 attaining NBPTS certification and sharing their expertise with 5 other teachers. 6 (2) The Excellent Teaching Program is created to 7 provide categorical funding for monetary incentives and bonuses for teaching excellence. The Department of Education 8 shall allocate and distribute to each school district an 9 10 amount as prescribed annually by the Legislature for the Excellent Teaching Program. Unless otherwise provided in the 11 12 General Appropriations Act, each school district's annual allocation shall be the sum of the amounts earned for the 13 following incentives and bonuses: 14 15 (a) A fee subsidy to be paid by the school district to the NBPTS on behalf of each individual who is an employee of 16 17 the district school board or a public school within that school district, who is certified by the district to have 18 demonstrated satisfactory teaching performance pursuant to s. 19 231.29 and, beginning in the school fiscal year 1999-2000, to 20 21 have qualified for the district performance-based pay incentive pursuant to s. 230.23, who satisfies the 22 prerequisites for participating in the NBPTS certification 23 24 program, and who agrees, in writing, to pay 10 percent of the NBPTS participation fee and to participate in the NBPTS 25 certification program during the school year for which the fee 26 27 subsidy is provided. The fee subsidy for each eligible participant shall be an amount equal to 90 percent of the fee 28 charged for participating in the NBPTS certification program, 29 30 but not more than \$1,800 per eligible participant. The fee subsidy is a one-time award and may not be duplicated for any 31

individual. 1 2 (b) A portfolio-preparation incentive of \$150 for each 3 teacher employed by the district school board or a public 4 school within the district who is participating in the NBPTS certification program. The portfolio-preparation incentive is 5 a one-time award paid during the school year for which the б 7 NBPTS fee subsidy is provided. (c) An annual bonus equal to 10 percent of the prior 8 fiscal year's statewide average salary for classroom teachers 9 10 to be paid to each individual who holds NBPTS certification 11 and is employed by the district school board or by a public 12 school within that school district. The district school board 13 shall distribute the annual bonus to each individual who meets the requirements of this paragraph and who is certified 14 15 annually by the district to have demonstrated satisfactory teaching performance pursuant to s. 231.29 and to have 16 17 qualified for the performance-based pay incentive pursuant to 18 s. 230.23. The annual bonus may be paid as a single payment or divided into not more than three payments. 19 (d) An annual bonus equal to 10 percent of the prior 20 fiscal year's statewide average salary for classroom teachers 21 to be paid to each individual who meets the requirements of 22 paragraph (c) and agrees, in writing, to provide the 23 24 equivalent of 12 workdays of mentoring and related services to 25 public school teachers within the district who do not hold NBPTS certification. The district school board shall 26 27 distribute the annual bonus in a single payment following the completion of all required mentoring and related services for 28 the year. It is not the intent of the Legislature to remove 29 30 excellent teachers from their assigned classrooms, therefore, credit may not be granted by a school district or public 31 3

school for mentoring or related services provided during the 1 2 regular school day or during the 196 days of required service 3 for the school year. 4 (e) The district shall receive an amount equal to 50 5 percent of the teacher bonuses provided under paragraph (c) 6 and (d), which shall be used by the district for professional 7 development of teachers. The district must give priority to using all funds received pursuant to this paragraph for 8 professional development of teachers employed at schools 9 10 identified as performing at critically low levels. 11 12 A teacher for whom the state pays the certification fee and who does not complete the certification program or does not 13 teach in a public school of this state for a least 1 year 14 15 after completing the certification program must repay the 16 amount of the certification fee to the state. However, a 17 teacher who completes the certification program but fails to 18 be awarded NBPTS certification is not required to repay the amount of the certification fee if the teacher meets the 19 1-year teaching requirement. Repayment is not required of a 20 21 teacher who does not complete the certification program or fails to fulfill the teaching requirement because of the 22 teacher's death or disability or because of other extenuating 23 24 circumstances as determined by the State Board of Education. 25 Section 17. Paragraph (a) of subsection (5) of section 236.081, Florida Statutes, as amended by chapter 97-380, Laws 26 27 of Florida, is amended to read: 236.081 Funds for operation of schools.--If the annual 28 allocation from the Florida Education Finance Program to each 29 30 district for operation of schools is not determined in the 31 annual appropriations act or the substantive bill implementing

However, if the renewal application form is not 6 received by the department or by the employing school district 7 before the expiration of the professional certificate, the application form, application fee, and a late fee must be 8 9 submitted before July 1 of the year following expiration of 10 the certificate in order to renew the professional certificate. The state board shall adopt rules to allow a 11 12 1-year extension of the validity period of a professional 13 certificate in the event of serious illness, injury, or other extraordinary extenuating circumstances of the applicant. The 14 15 department shall grant such 1-year extension upon written 16 request by the applicant or by the superintendent of the local 17 school district or the governing authority of a developmental research school, state-supported school, or nonpublic school 18 that employs the applicant. 19 (3) For the renewal of a professional certificate, the 20 21 following requirements must be met: (b) In lieu of college course credit or inservice 22 points, the applicant may renew a specialization area by 23 24 passage of a state board approved subject area test, by completion of the national certification from the National 25 Board for Professional Teaching Standards in that 26 27 specialization area, or by completion of a department approved summer work program in a business or industry directly related 28 to an area of specialization listed on the certificate. The 29 30 state board shall adopt rules providing for the approval 31 procedure.
