23	<u>person when such other person is located in a dwelling,</u>		
24	<u>structure, or conveyance and such location provides a</u>		
25	<u>reasonable expectation of privacy.</u>		
26	<u>(2) A person may be convicted of and sentenced</u>		
27	<u>separately for a violation of this section and for any other</u>		
28	<u>criminal offense, including, but not limited to, burglary,</u>		
29	<u>trespass, or loitering.</u>		
30	<u>(3) A person who violates this section commits:</u>		
31	<u>(a) A misdemeanor of the first degree for the first</u>

 18 criminal mischief in which the damage occurred  
 19 during one scheme or course of conduct;  
 20 creating s. 810.14, F.S.; prohibiting a person  
 21 from secretly observing or committing other  
 22 acts against another person with lewd,  
 23 lascivious, or indecent intent when the other  
 24 person is in a location that provides a  
 25 reasonable expectation of privacy; providing  
 26 that a person may be convicted and sentenced  
 27 separately for the voyeurism offense and for  
 28 any other criminal offense; providing for  
 29 criminal penalties; providing an effective  
 30 date.
