Section 4. Subsection (1) of section 322.21, Florida  
Statutes, is amended to read:

322.21 License fees; procedure for handling and  
collecting fees.--

(1) Except as otherwise provided herein, the fee for:

(a) An original or renewal commercial driver's license  
is \$50, which shall include the fee for driver education  
provided by s. 233.063; however, if an applicant has completed  
training and is applying for employment or is currently  
employed in a public or nonpublic school system that requires  
the commercial license, the fee shall be the same as for a  
Class E driver's license. A delinquent fee of \$1 shall be  
added for a renewal made not more than 12 months after the  
license expiration date.

1 (b) An original Class D or Class E driver's license is  
2 \$20, which shall include the fee for driver's education  
3 provided by s. 233.063; however, if an applicant has completed  
4 training and is applying for employment or is currently  
5 employed in a public or nonpublic school system that requires  
6 a commercial driver license, the fee shall be the same as for  
7 a Class E license.

8 (c) The renewal or extension of ~~a Class D or Class E~~  
9 ~~driver's license or of a license restricted to motorcycle use~~  
10 only is \$15, except that a delinquent fee of \$1 shall be added  
11 for a renewal or extension made not more than 12 months after  
12 the license expiration date. The fee provided in this  
13 paragraph shall include the fee for driver's education  
14 provided by s. 233.063.

15 (d) The renewal or extension of a Class D or Class E  
16 driver's license for an individual who obtains a 4-year  
17 renewal pursuant to s. 322.18(2)(b) is \$40, except that a  
18 delinquent fee of \$1 shall be added for a renewal or extension  
19 made not more than 12 months after the license expiration  
20 date. The fee provided in this paragraph shall include the fee  
21 for driver's education provided by s. 233.063.

22 (e) The renewal or extension of a Class D or Class E  
23 driver's license for an individual who obtains a 6-year  
24 renewal pursuant to s. 322.18(2)(b), shall be free of charge.

25 ~~(f)~~(d) An original driver's license restricted to  
26 motorcycle use only is \$20, which shall include the fee for  
27 driver's education provided by s. 233.063.

28 ~~(g)~~(e) Each endorsement required by s. 322.57 is \$5.
