23	1. Funds to be credited to the trust fund shall
24	consist of federal social services block grant funds. Funds
25	shall be used for the purpose of providing health care and
26	support services to department clients and for other such
27	purposes as may be appropriate and shall be expended only
28	pursuant to legislative appropriation or an approved amendment

Notwithstanding the provisions of s. 216.301 and 2 pursuant to s. 216.351, any balance in the trust fund at the 3 end of any fiscal year shall remain in the trust fund at the 4 end of the year and shall be available for carrying out the 5 purposes of the trust fund. 6 (2) Pursuant to the provisions of s. 19(f)(2), Art. 7 III of the State Constitution, each trust fund listed in 8 subsection (1) shall, unless terminated sooner, be terminated on July 1, 2001.
