Subsection (12) of section 465.003, Florida Statutes, is amended to read: 13 14 465.003 Definitions.--As used in this chapter, the 15 term: 16 "Practice of the profession of pharmacy" includes (12)17 compounding, dispensing, and consulting concerning contents, therapeutic values, and uses of any medicinal drug; and 18 19 consulting concerning therapeutic values and interactions of 20 patent or proprietary preparations, whether pursuant to 21 prescriptions or in the absence and entirely independent of 22 such prescriptions or orders; and other pharmaceutical 23 services. The phrase also includes any other act, service, 24 operation, research, or transaction incidental to, or forming 25 a part of, any of the foregoing acts, requiring, involving, or 26 employing the science or art of any branch of the 27 pharmaceutical profession, study, or training, and shall 28 expressly permit a pharmacist to transmit information from 29 persons authorized to prescribe medicinal drugs to their

established protocol, a pharmacist practicing under this chapter may initiate or modify any drug therapy and therapeutic management which is authorized within the framework of a written protocol established with an authorized supervisory practitioner. Section 2. Section 465.188, Florida Statutes, is created to read: 465.188 Initiation and modification of drug therapy and therapeutic management by pharmacist .-- In addition to the provisions of this chapter that allow a pharmacist to perform pharmaceutical services independently of an established protocol, a pharmacist may initiate or modify drug therapy and

therapeutic management, including the administering of immunizations, pursuant to a written protocol established with 14 a supervisory practitioner who is a physician licensed under 15

chapter 458 or chapter 459. The supervisory practitioner may

delegate to any pharmacist licensed under this chapter the authority to initiate or modify the drug therapy and

19 therapeutic management of the practitioner's patients, but

only if such therapy and management is within the framework of

a written protocol established between such practitioner and

pharmacist. A pharmacist who, pursuant to such a protocol, has accepted authority to initiate or modify drug therapy and

therapeutic management under this section must:

(1) Clearly inform the patient that she or he is a pharmacist and that the patient has the right to see the supervisory practitioner prior to initiation or modification of the drug therapy and therapeutic management by the pharmacist.
