## I. Summary:

This bill provides for the Department of Environmental Protection to make available to the Southern Waste Information Exchange, Inc., an annual appropriation from the Solid Waste Management Trust Fund to assist Florida's public and private sectors with solid and hazardous waste management.

# II. Present Situation:

The Southern Waste Information Exchange, Inc., (SWIX), is a nonprofit Florida 501(c)(3) organization formed through a cooperative partnership by Florida State University, the Florida Chamber of Commerce, and the Florida Department of Environmental Protection. SWIX assists industrial and commercial waste generators with the management of solid and hazardous waste and serves as a clearinghouse and repository for industry concerning information on:

- Market development;
- Recycled products;
- Solid and hazardous waste management;
- Current regulations and legislation;
- Alternative and emerging waste management technologies;
- Trade journals and associations;
- The availability of and demand for waste materials; and
- Waste management services and products.

Since its inception in 1981, the emphasis of SWIX has been to encourage and facilitate sound environmental and cost-effective alternatives to land filling, incineration, or treatment of solid waste, through direct interaction with waste generators in both the public and private sectors.

SWIX produces a catalog that is designed to assist industry in the area of solid and hazardous waste management. The catalog provides up-to-date information concerning the availability of

and demand for waste materials as well as providing information related to waste management services and products. The catalog is published three times a year and is distributed to government agencies and private firms in the southeastern United States.

SWIX is currently funded from the Solid Waste Management Trust Fund for \$300,000 in FY 1998-1999.

## III. Effect of Proposed Changes:

This bill provides that the Legislature recognizes the need for statewide solid and hazardous waste management assistance to Florida's private businesses, industries, and the public sector, including local units of government. In order to assist the Department of Environmental Protection in providing solid and hazardous waste management assistance to Florida's public and private sectors on a continuing basis, the Legislature recognizes the need for a waste exchange as part of the state's comprehensive solid and hazardous waste management programs. This bill designates the Southern Waste Information Exchange, Inc., (SWIX) as a provider of this service to Florida's private and public sectors.

The Department of Environmental Protection (department) shall make available to the Southern Waste Information Exchange, Inc., an annual appropriation from the Solid Waste Management Trust Fund. These funds shall be used by SWIX to maintain and expand a waste exchange service and other solid and hazardous waste management assistance as requested by the private sector, the department, and local governments.

# B. Private Sector Impact:

According to the June 30, 1998, final report from SWIX, approximately 281,004 tons of waste materials (with an estimated cost-savings in disposal costs to waste generators of \$13,596,711) were successfully recycled, used, or reused. This amounted to a cost/benefit ratio of \$1:\$30. This means that for every state dollar invested in the operation of the SWIX program, \$30 was avoided in disposal costs to waste generators. The bill would statutorily recognize SWIX and its role in assisting the private sector, particularly small businesses, in their waste reduction and management practices.

# C. Government Sector Impact:

The current proposal (April 14, 1999) by the General Government Conference includes \$300,000 funding for SWIX from the Solid Waste Management Trust Fund.

#### VIII. Amendments:

# 1 by Fiscal Policy Committee: (WITH TITLE AMENDMENT):

Amends section 403.703, F.S., to add a new definition to this section for a "hazardous waste transfer facility." Such a facility includes any transportation-related storage facility including loading docks, parking lots, and storage areas where hazardous waste is stored for a period of more than 24 hours, but not more than 10 days.

## # 2 by Fiscal Policy Committee:

Specifies that the Department of Environmental Protection shall make an annual allocation to the Southern Waste Information Exchange, Inc., from the Solid Waste Management Trust Fund contingent upon the availability of such funds.
