I. SUMMARY:

This legislation re-creates the Florida International Trade and Promotion Trust Fund without modification effective November 4, 2000. The Florida International Trade and Promotion Trust Fund, FLAIR #312338 is administered by the Executive Office of the Governor. This fund was last re-created effective November 4, 1996, by Chapter 95-085, L.O.F.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 288.826, F.S., creates the trust fund and provides for its purpose. Section 212.0606, F.S., provides for its revenues.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

Used for the operation of Enterprise Florida and for the operation of Florida foreign offices as provided under section 288.012, F.S.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

Surcharges on car rental fees. According to Comptroller data, receipts to this fund for FY 1997-98 were \$5.6 million.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.

C. STATUTE(S) AFFECTED:

None

III. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT:

This legislation has no fiscal impact on state agencies or state funds, on local governments as a whole or on the private sector. It simply re-creates, without modification, an existing state trust fund and continues the current use of the fund.
