I. SUMMARY:

This legislation re-creates the Division of Administration Knott Data Center Working Capital Trust Fund without modification, effective November 4, 2000. The Division of Administration Knott Data Center Working Capital Trust Fund, FLAIR #482792, is administered by the Department of Education. This fund was last re-created effective November 4, 1996, by Chapter 95-108, LOF.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 216.272, F.S., creates the trust fund.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The trust fund allows the Department of Education to provide sufficient funds for the operation of the Knott Data Center.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the Division of Administration Knott Data Center Working Capital Trust Fund are data processing funds appropriated to the budget entities that are served by the Knott Data Center. According to Comptroller data, receipts to this fund for FY 1997-98 were \$4.2 million.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.

C. STATUTE(S) AFFECTED:

None.

III. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT:

This legislation has no fiscal impact on state agencies or state funds, on local governments as a whole or on the private sector. It simply re-creates, without modification, an existing state trust fund and continues the current use of the fund.
