I. SUMMARY:

This legislation re-creates the Alec P. Courtelis Capital Facilities Matching Trust Fund without modification, effective November 4, 2000. The Alec P. Courtelis Capital Facilities Matching Trust Fund, FLAIR #492070, is administered by the State University System. This fund was last re-created effective November 4, 1996, by Chapter 95-29.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 240.2601, F.S., creates the trust fund.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The purpose of the fund is to establish a depository for the purpose of providing matching funds for private contributions to be used for the development of high priority instructional and research capital facilities within the State University System.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are General Revenue and the Educational Enhancement Trust Fund. According to Comptroller data, receipts to this fund for FY 1997-98 were \$18 million.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.

C. STATUTE(S) AFFECTED:

None.

III. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT:

This legislation has no fiscal impact on state agencies or state funds, on local governments as a whole or on the private sector. It simply re-creates, without modification, an existing state trust fund and continues the current use of the fund.
