I. FINAL ACTION STATUS:

HB 1249 passed the House on March 9, 1999, and passed the Senate on March 16, 1999. The bill was approved by the Governor and became law April 6, 1999 (Chapter 99-60, Laws of Florida).

II. SUMMARY:

This legislation re-creates the Contracts and Grants Trust Fund without modification, effective November 4, 2000. The Contracts and Grants Trust Fund, FLAIR #42-2-133, is administered by the Department Agriculture and Consumer Services. This fund was last re-created effective November 4, 1996, by Chapter 95-54, Laws of Florida.

III. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

This trust fund was created in Chapter 84-220, Laws of Florida, (the 1984-85 General Appropriations Act) and is not contained in the Florida Statutes. Section 589.277, F.S., provides a revenue source for the fund.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

This trust fund is used to monitor and track federal funds administered by the Department.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for this fund are various Federal grants and contracts. According to Comptroller data, receipts to this fund for FY 1997-98 were \$9.6 million.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.

C. STATUTE(S) AFFECTED:

None.

IV. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT:

This legislation has no fiscal impact on state agencies or state funds, on local governments as a whole or on the private sector. It simply re-creates, without modification, an existing state trust fund and continues the current use of the fund.
