I. SUMMARY:

This legislation re-creates the Market Improvements Working Capital Trust Fund without modification, effective November 4, 2000. The Market Improvements Working Capital Trust Fund, FLAIR #42-2-473, is administered by the Department of Agriculture and Consumer Services. This fund was last re-created effective November 4, 1996, by Chapter 95-59, Laws of Florida.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 570.531, F.S., creates the trust fund.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund is the sole depository for funds collected by, or appropriated for, agricultural marketing facilities. Only costs associated with the operation, maintenance, and expansion of agricultural marketing facilities are authorized from the fund.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

Revenue comes from fees charged to Agricultural Marketers for leased space and truck scales. These fees are imposed on buyers, brokers, and other users of State Farmers Markets. According to Comptroller data, receipts to this fund for FY 1997-98 were \$4.1 million.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
