The fee for application for change of location shall be \$25. Any applicant for renewal who has failed to submit his or her renewal application by October 1 shall pay a renewal application fee equal to the original application fee. No fee is refundable. All fees shall be deposited into the Highway Safety Operating Trust ~~General Revenue~~ Fund.
