I. FINAL ACTION STATUS:

HB 1283 passed the House on March 9, 1999, and passed the Senate on March 16, 1999. The bill was approved by the Governor and became law April 6, 1999 (Chapter 99-76, Laws of Florida).

II. SUMMARY:

This legislation re-creates the Working Capital Trust Fund without modification, effective November 4, 2000. The Working Capital Trust Fund, FLAIR #44-2-792, is administered by the Department of Banking and Finance. This fund was last re-created effective November 4, 1996, by Chapter 95-78, Laws of Florida.

## III. SUBSTANTIVE ANALYSIS:

- A. PRESENT SITUATION:
  - 1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 216.272, F.S., creates the trust fund and provides as a revenue source charges against user entities.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund provides for the operation of the department's data processing center. This may include the creation of a reserve account within the Working Capital Trust Fund to pay for future information technology resource acquisitions as appropriated by the Legislature.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are assessments to the agency's operating divisions for data processing services. According to Comptroller data, receipts to this fund for FY 1997-98 were \$897,554.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
