Be It Enacted by the Legislature of the State of Florida:

Section 1. (1) The Securities Guaranty Fund within the Department of Banking and Finance, FLAIR number 44-2-626, which was created by section 517.131, Florida Statutes, and which is to be terminated pursuant to Section 19(f), Article III of the State Constitution on November 4, 2000, is re-created.

(2) All current balances of the fund are carried forward, and all current sources and uses of the fund are continued.
