I. FINAL ACTION STATUS:

HB 1323 passed the House on March 9, 1999, and passed the Senate on March 16, 1999. The bill was approved by the Governor and became law April 6, 1999 (Chapter 99-94, Laws of Florida).

II. SUMMARY:

This legislation re-creates the Water Management Lands Trust Fund without modification, effective November 4, 2000. The Water Management Lands Trust Fund, FLAIR #37-2-776, is administered by the Department of Environmental Protection. This fund was last re-created effective November 4, 1996 by Chapter 95-373, Laws of Florida.

III. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 373.59, F.S., creates the trust fund and provides for its purposes. Sections 201.15, 373.129, 373.430, and 373.584, F.S., provide revenue sources for the fund.

BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The trust fund was created to provide funds to the five Water Management Districts for the purpose of land acquisition, management, maintenance, capital improvements and administration of purchased lands.

MAJOR SOURCES OF REVENUE FOR THE FUND:

The major source of revenue for the Water Management Lands Trust Fund is a documentary stamp tax. According to Comptroller data, receipts to this fund for FY 1997-98 were \$96.2 million.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.

C. STATUTE(S) AFFECTED:

None.
