## I. SUMMARY:

This legislation re-creates the Working Capital Trust Fund without modification, effective November 4, 2000. The Working Capital Trust Fund, FLAIR #37-2-792, is administered by the Department of Environmental Protection. This fund was last re-created effective November 4, 1996, by Chapter 95-47, Laws of Florida.

## II. SUBSTANTIVE ANALYSIS:

#### A. PRESENT SITUATION:

MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 216.272, F.S., creates the trust fund.

BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund provides for the ongoing operation of the department's data processing center and future information technology resource acquisition.

MAJOR SOURCES OF REVENUE FOR THE FUND:

The major source of revenue for the fund is assessments to the divisions within the Department of Environmental Protection for data processing services. According to Comptroller data, receipts to this fund for FY 1997-98 were \$7.7 million.

## B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.

C. STATUTE(S) AFFECTED:

None.

#### III. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT:

This legislation has no fiscal impact on state agencies or state funds, on local governments as a whole or on the private sector. It simply re-creates, without modification, an existing state trust fund and continues the current use of the fund.
