### I. SUMMARY:

This legislation re-creates the Forfeited Property Trust Fund without modification, effective November 4, 2000. The Forfeited Property Trust Fund, FLAIR #37-2-267, is administered by the Department of Environmental Protection. This fund was last re-created effective November 4, 1996, by Chapter 95-37, Laws of Florida.

# II. SUBSTANTIVE ANALYSIS:

#### A. PRESENT SITUATION:

#### MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Subsection 253.03(12), F.S., creates the trust fund. Section 895.09, F.S., provides for the distribution of proceeds from the sale of forfeited property.

## BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund supports the administration, management, control, protection, and selling of real property forfeited to the state through a non-lapsing revolving fund.

#### MAJOR SOURCES OF REVENUE FOR THE FUND:

The major source of revenue for the fund is the proceeds from the sale of real property forfeited to the state. According to Comptroller data, receipts to this fund for FY 1997-98 were \$479,528.

### B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
