I. SUMMARY:

This legislation re-creates the State Park Trust Fund without modification, effective November 4, 2000. The State Park Trust Fund, FLAIR #37-2-675, is administered by the Department of Environmental Protection. This fund was last re-created effective November 4, 1996, by Chapter 95-45, Laws of Florida.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 258.034, F.S., creates the trust fund. Sections 258.014 and 260.016, F.S., provide revenue sources for the fund.

BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The funds collected shall be expended for the support, maintenance, preservation and improvement of any monument, memorial, historic site or state park assigned to the department.

MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are state park user fees and transfers from the Land Acquisition Trust Fund. According to Comptroller data, receipts to this fund for FY 1997-98 were \$65.2 million.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
