I. FINAL ACTION STATUS:

HB 1369 passed the House on March 9, 1999, and passed the Senate on March 16, 1999. The bill was approved by the Governor and became law April 6, 1999 (Chapter 99-115, Laws of Florida).

II. SUMMARY:

This legislation re-creates the State Property Insurance Trust Fund without modification, effective November 4, 2000. The State Property Insurance Trust Fund, FLAIR # 46-2-291, is administered by the Department of Insurance. This fund was last re-created effective November 4, 1996, by Chapter 96-28, Laws of Florida.

III. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 284.01, F.S., creates the trust fund, provides for its purpose, and provides for revenues. See also sections 284.02 thru 284.17, F.S.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

Provides a self-insurance pool for state agencies for the payment of property damage claims to state buildings or their contents.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

Insurance premiums paid by state agencies. According to Comptroller data, receipts to this fund for FY 1997-98 were \$13 million.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.

C. STATUTE(S) AFFECTED:

None

IV. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT:

This legislation has no fiscal impact on state agencies or state funds, on local governments as a whole or on the private sector. It simply re-creates, without modification, an existing state trust fund and continues the current use of the fund.
