(1) The Insurance Commissioner's Regulatory Trust Fund within the Department of Insurance, FLAIR number 46-2-393, which was created by section 624.523, Florida Statutes, and which is to be terminated pursuant to Section 19(f), Article III of the State Constitution on November 4, 2000, is re-created.

(2) All current balances of the trust fund are carried forward, and all current sources and uses of the trust fund are continued.
