Are incorporated pursuant to chapter 617; and 25 2.b. Hold a current exemption from federal corporate 26 income tax liability pursuant to s. 501(c)(3) of the Internal 27 Revenue Code of 1986, as amended; and 28 3.a.2. Sponsor golf tournaments sanctioned by the PGA 29 Tour, PGA of America, or the LPGA; or-30 b. Are funded primarily by county or municipal

governments and have as their primary purpose the
