Membership; terms of office; officers; 20 quorum; meetings; removal .--21 (1) The authority shall consist of seven five members. 22 As a condition of eligibility for appointment and to hold office, four members must shall reside within the 23 municipality; two members must city and one member shall 24 reside within the Greater Boca Raton Reserve Area, as defined 25 26 in chapter 67-1112, Laws of Florida; and one member must 27 reside within the municipality and west of the airport. 28 (2) All members of the authority shall be representatives of the business and professional community, 29 homeowners, and users of the airport. The county commission 30 31 shall appoint two members, each of whom must reside the member 1

who resides within the Greater Boca Raton Reserve Area.+The 1 city council shall appoint five members, four of whom must 2 reside within the limits of the municipality and one of whom 3 must reside within the limits of the municipality and west of 4 5 the airport.one member from a list of nominees of the Boca б Raton Pilots Association or its successor; one member from the 7 city council's own nominees; one member from a list of 8 nominees of the Boca Raton Federation of Homeowners Associations; and one member from a list of nominees of the 9 Boca Raton Chamber of Commerce. Each list of nominees, except 10 11 that of the county commission and of the city council, shall 12 consist of not less than three names of persons qualified to 13 hold office. Each nominating entity except the county 14 commission and the city council shall file its list of nominees not later than May 1 of the year of expiration of the 15 term of office of the member nominated by the entity. If a 16 list of nominees is not timely filed with the city council, 17 the city council shall proceed to fill the vacancy by 18 appointment from its own nominations.
