I. SUMMARY:

This bill establishes specific completion dates for the next performance audits for certain Hillsborough County agencies. The new audit schedule requires completed performance audits every eight years instead of the current 4 years.

The bill appears to have an insignificant fiscal impact.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

Performance audits for eight Hillsborough County agencies created by special act are now on a 4-year recurring cycle for completing performance audits.

The eight agencies are:

- Tampa Port Authority;
- Hillsborough County City-County Planning Commission;
- Hillsborough County Environmental Protection Commission;
- Hillsborough County Hospital Authority;
- Hillsborough County Aviation Authority;
- Hillsborough County Public Transportation Commission;
- Hillsborough County Civil Service Board; and
- Tampa Sports Authority.

Pursuant to s. 125.01, Florida Statutes, "[e]ntities that are funded wholly or in part by the county, at the discretion of the county, may be required by the county to conduct a performance audit paid for by the county . . ."

According to the Hillsborough County Legislative Delegation Staff Summary dated January 7, 1999, the delegation voted to delay the next audits by one year instead of eight with consensus that an interim study be conducted to determine ongoing need for such audits.

B. EFFECT OF PROPOSED CHANGES:

This bill doubles the length of time between audits. The bill establishes the following schedule, with the corresponding agencies, for the completion of performance audits:

- (1) Tampa Port Authority and the Hillsborough County City-County Planning Commission: **April 30, 2001**.
- (2) Hillsborough County Environmental Protection Commission and Hillsborough County Hospital Authority: **April 30, 2002**.
- (3) Hillsborough County Aviation Authority and Hillsborough County Public Transportation Commission: **April 30, 2003**.
- (4) Hillsborough County Civil Service Board and Tampa Sports Authority: April 30, 2004.
