WHEREAS, on July 18, 1995, at 1:41 a.m., Jeremy Stewart was operating his motorcycle in the City of Sanibel, and

WHEREAS, at that time a City of Sanibel police officer, responding to a routine backup call, drove a vehicle owned by the City of Sanibel at an excessive rate of speed on a wet road and lost control of the vehicle, crossing the center line of the roadway and striking Jeremy Stewart in his lane of traffic, and

WHEREAS, Jeremy Stewart was transported to Lee Memorial Hospital where he displayed signs of intra-abdominal bleeding, which were suggestive of a ruptured spleen, and

WHEREAS, Jeremy Stewart was immediately taken to surgery where Dr. Timothy Hughes discovered that Jeremy Stewart's spleen had been ripped apart beyond repair and subsequently performed a splenectomy, and

WHEREAS, Jeremy Stewart had also sustained facial and leg lacerations and had an open left humeral fracture with obvious nerve involvement, and

WHEREAS, during the months following the accident, Jeremy Stewart's humeral fracture began to heal and, as it did, it became apparent that he had incurred a permanent loss of his radial nerve function in his left arm and left hand, 31 and

WHEREAS, because Jeremy Stewart was left-handed and the radial nerve damage to Jeremy Stewart's left arm and hand had rendered his left arm and hand useless, Jeremy Stewart's local orthopedic surgeon referred him to an expert in Tampa, Dr. John Rayhack, and

WHEREAS, Dr. John Rayhack advised Jeremy Stewart that a tendon transfer was the only hope of regaining the use of his left arm and hand, and

WHEREAS, upon completion of the surgery and rehabilitation, Jeremy Stewart had regained approximately 60 percent of the use of his arm, and

WHEREAS, Dr. Rayhack has theorized that Jeremy Stewart might be able to regain as much as 90 percent of his strength, but would still lack dexterity, and

WHEREAS, the serious injuries sustained by Jeremy Stewart as a result of the accident formed the basis of legal action brought by Jeremy Stewart against the City of Sanibel, and

WHEREAS, the case was tried before a jury in Fort Myers in the 20th Judicial Circuit, and

WHEREAS, at trial Dr. Timothy Hughes testified that as a result of losing his spleen, Jeremy Stewart's immune system may become overwhelmed by certain types of infections and that he runs the risk of dying from overwhelming sepsis, and

WHEREAS, rehabilitation experts for both the defense and the plaintiff also testified that, because of the loss of strength and dexterity in his left hand and arm, Jeremy Stewart would never be able to return to his previous occupation as a wallpaper hanger and painter, and

WHEREAS, the City of Sanibel admitted that the accident 31 | in which Jeremy Stewart was injured was the fault of the City
