I. <u>SUMMARY</u>:

Primarily, the bill offers the Key West Utility Board some flexibility in conducting its purchasing and disbursement duties.

The bill does not have a fiscal impact with regard to implementing the provisions of this bill.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

Chapter 69-1191, Florida Laws of Florida, as amended by chapters 75-410, 75-412, and 75-396, Laws of Florida, creates the Utility Board (board) of the City of Key West. The special act provides that the board has complete and exclusive power and right to manage, operate, maintain, and control the electric public utility owned by Key West.

All disbursements made by the board relating to electric services, materials and commodities, byproducts and water, steam or heat from any activities or operations must be paid out only upon the approval of the board.

Only construction, repairs, or work made by the board and exceeding \$15,000 is required to be performed under contract or contracts entered into by the board. In addition, supplies, equipment, machinery, and materials costing \$10,000 or more must be purchased only after the items are bided out.

B. EFFECT OF PROPOSED CHANGES:

This bill permits the Key West Utility Board (board) to make disbursements relating to the purchase of electric services, material and commodities pursuant to policies adopted by the board or policies established by resolution adopted by the board.

The bill eliminates the \$15,000 minimum cost requirement for placing construction and repair work by the board under contract. The bill now provides that the amount that determines whether or not certain work can be placed under contract or contracts is established by resolution adopted by the board.

The bill eliminates requiring the board to implement a bid process for the purchase of those supplies, equipment, and machinery costing \$10,000 or more. Instead that amount is established by resolution adopted by the board.

Section 1. Amends section 11 of chapter 69-1191, Laws of Florida, as amended by chapters 75-410, 75-412, and 75-396, Laws of Florida; permits the Key West Utility Board to issue disbursements representing payment for products and services pursuant to policies adopted by the board or policies established by resolutions adopted by the board.

Section 2. Amends section 13 of chapter 69-1191, Laws of Florida, as amended by chapters 84-457 and 95-509, Laws of Florida; providing that certain construction and repair work exceeding the amount established by resolution adopted by the board must be done under contract or contracts entered into by the board after undergoing a bidding process; and provides that all supplies, equipment, machinery and materials costing more than the amount established by resolution adopted by the board must be purchased only after implementing a bidding process.
