15	On page 1, line 26, through page 2, line 20, delete

19	(2) <u>A minor may not ride on the bed of a pickup truck</u>		
20	<u>or flatbed truck unless the truck has factory-installed</u>		
21	<u>seating in the bed, or has been modified to include in the bed</u>		
22	<u>secure seating and safety restraints that would prevent the</u>		
23	<u>minor from falling, jumping, or being thrown from the truck,</u>		
24	<u>and the minor is securely restrained in such seating.</u> <del>No</del>		
25	<del>person shall ride on any vehicle upon any portion thereof not</del>		
26	<del>designed or intended for the use of passengers. This provision</del>		
27	<del>shall not apply to an employee engaged in the necessary</del>		
28	<del>discharge of a duty or to a person or persons riding within</del>		
29	<del>truck bodies in space intended for merchandise.</del> <u>Any operator</u>

1 violation, punishable as provided in chapter 318. However,  
 2 nothing in this section may be construed to prohibit a local  
 3 governmental entity from enacting an ordinance that prohibits  
 4 any person other than an employee engaged in the discharge of  
 5 his or her duties from riding in or otherwise occupying the  
 6 open bed of a truck being operated upon any street or highway  
 7 within its territorial limits. A person who violates such an  
 8 ordinance is subject to the penalties provided in this  
 9 subsection.
