Paragraph (c) is added to subsection (15) 15 16 of section 196.012, Florida Statutes, to read: 17 196.012 Definitions. -- For the purpose of this chapter, the following terms are defined as follows, except where the 18 19 context clearly indicates otherwise: 20 (15) "New business" means: 21 (c)1. An arts or cultural organization that is tax 22 exempt under s. 501(c)(3) of the Internal Revenue Code of 23 1986, as amended; or 24 2. Any person or entity that is building or renovating 25 improvements to real property which will include theater 26 space, an art gallery open to the public, or some other 27 improvement that is dedicated to the development and 28 exhibition of the performing or visual arts. Section 2. Present subsections (6), (7), (8), and (9) 29 30 of section 196.1995, Florida Statutes, are redesignated as 31

          (6) With respect to a new business as defined in s.

    196.012(15)(c), the taxing authority having jurisdiction to

           Section 3. The Legislature recognizes that the Central

    Florida Theatre Alliance has been formed to promote the
    theatrical arts within a 30-mile radius of Downtown Orlando

    and that it is dedicated to making Orlando a world-class
    theater community. In recognition of the value of this

    endeavor to the community and the state, the Legislature

    declares the Central Florida Theatre Alliance to be the
    premier umbrella organization for the promotion of theater in
