I. SUMMARY:

HB 379 prohibits the sale or purchase of dog and cat furs and pelts as follows:

- The bill provides that it is a first degree misdemeanor for any person to sell any garment which contains dog or cat fur.
- The bill provides that it is a first degree misdemeanor for any person to sell or give away the pelt
 of a dog or cat.
- The bill provides that it is a third degree felony for any person to engage in the business of a
 dealer or buyer in the pelts or furs of any dog or cat or to purchase such pelts or furs within the
 state. Also, no common carrier shall knowingly ship any dog or cat furs or pelts.
- The bill provides that it is a third degree misdemeanor for any person to kill a dog or cat with the sole intent of selling or giving away the pelt of the animal.
- The bill provides that a person who possesses, imports, sells, buys, gives away, or accepts any
 pelt of a dog or cat with the sole intent of selling or giving away the pelt of the dog or cat commits
 a first degree misdemeanor.
- The bill provides that a person who possesses, imports, sells, buys, gives away, or accepts any
 dog or cat with the sole intent of killing the dog or cat for the purpose of selling the pelt of the dog
 or cat commits a third degree felony.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

The Humane Society of the United States has reported that garments made from the fur of domesticated dogs and cats are being produced in Asia and marketed in the United States. These products consist of coats, jackets, fur-trimmed garments, and animal figurines.

Presently, Florida has no laws regarding the sale of garments containing dog or cat fur, the possession, sale or purchase of dog or cat pelts, or the killing of dogs or cats for the sole purpose of selling or giving away the pelt. California, Pennsylvania and Georgia currently have statutes which prohibit the trafficking of dog or cat furs or pelts.

Cruelty to Animals

Chapter 828 of the Florida Statutes deals generally with treatment of animals. Section 828.12 prohibits cruelty to animals as follows:

- (1) A person who unnecessarily overloads, overdrives, torments, deprives of necessary sustenance or shelter, or unnecessarily mutilates, or kills any animal, or causes the same to be done, or carries in or upon any vehicle, or otherwise, any animal in a cruel or inhumane manner, is guilty of a misdemeanor of the first degree, punishable as provided in s. 775.082 or by a fine of not more than \$5,000, or both.
- (2) A person who intentionally commits an act to any animal which results in the cruel death, or excessive or repeated infliction of unnecessary pain or suffering, or causes the same to be done, is guilty of a felony of the third degree, punishable as provided in s. 775.082 or by a fine of not more than \$10,000, or both.

Confinement of Animals

Section 828.13(2) prohibits the confinement of animals without sufficient food, water or exercise as follows:

(2) Whoever:

- (a) Impounds or confines any animal in any place and fails to supply the animal during such confinement with a sufficient quantity of good and wholesome food and water,
- (b) Keeps any animals in any enclosure without wholesome exercise and change of air, or
- (c) Abandons to die any animal that is maimed, sick, infirm, or diseased,

is guilty of a misdemeanor of the first degree, punishable as provided in s. 775.082 or by a fine of not more than \$5,000, or by both imprisonment and a fine.

Fur and Hide Dealers

Section 372.66 provides that it is unlawful for any person to engage in the business of a dealer or buyer in alligator skins or green or dried furs until such person has been licensed as provided in the section.

B. EFFECT OF PROPOSED CHANGES:

HB 379 creates three new sections of statute as follows:

Sale of Garments Containing Dog and Cat Fur

The bill creates section 501.151 which provides that it is unlawful for any person to sell or offer for sale in this state any garment containing dog or cat fur. This new section is placed within chapter 501 which is titled "Consumer Protection". The section also makes it unlawful for any person to sell or offer for sale or to give away the pelt of any dog or cat. Violations of these provisions constitute a first degree misdemeanor. A first degree misdemeanor is punishable by up to one year in jail. A second or subsequent conviction for a violation of these provisions constitutes a third degree felony. A third degree felony is punishable by a term of imprisonment not exceeding five years.

The bill also provides that "the department" may institute proceedings in the appropriate circuit court to enforce compliance with the provisions of this section. In section 501.145, the section immediately preceding this newly created section, the word "department" is defined as the Department of Agriculture and Consumer Affairs. The department is entitled to seek a civil penalty of up to \$5,000 for each violation of the section.

Dealing in the Business of Buying Pelts or Furs

The bill amends section 372.66 to provide that it is unlawful for any person to engage in the business of a dealer or buyer in the pelts or furs of any dog or cat in the state or to purchase such pelts or furs within the state. The section also prohibits a common carrier from knowingly shipping or transporting any dog or cat pelts or furs within the state. Violations of these provisions constitute a third degree felony.

Killing Dog or Cat with Intent to Sell or Give Away Pelt

This bill also creates section 828.123 which prohibits the killing of any dog or cat with the sole intent of selling or giving away the pelt. A violation of this provision is a third degree felony punishable by a fine of not more than \$10,000 or by both imprisonment and a fine.

This section also provides that a person who "possesses, imports into this state, sells, buys, gives away, or accepts any pelt of a dog or cat with the sole intent of selling or giving away the pelt of the dog or cat" commits a first degree misdemeanor. This provision is punishable by a definite term of imprisonment not exceeding one year or by a fine of \$5,000 or by both imprisonment and a fine.

Further, the section prohibits the possession, importation into the state, selling, buying, giving away, or accepting of any dog or cat with the sole intent of killing such dog or cat, or having such dog or cat killed, for the purpose of selling or giving away the pelt of such animal. A violation of this provision is punishable by a term of imprisonment not exceeding 5 years or by a fine of not more than \$10,000 or by both imprisonment and a fine.

Section 1: Prohibits sale of garments or items containing dog or cat fur.

<u>Section 2</u>: Prohibits person from engaging in the business of a dealer or buyer in the pelts or furs of any dog or cat in the state. Prohibits common carrier from knowingly shipping or transporting any dog or cat fur within the state.

<u>Section 3</u>: Prohibits killing a cat or dog with the sole purpose of selling or giving away the pelt. Prohibits sale, possession, purchase of dog or cat pelt.

IV. CONSEQUENCES OF ARTICLE VII, SECTION 18 OF THE FLORIDA CONSTITUTION:

A. APPLICABILITY OF THE MANDATES PROVISION:

This bill does not require counties or municipalities to spend funds or to take action requiring the expenditure of funds.

B. REDUCTION OF REVENUE RAISING AUTHORITY:

This bill does not reduce the authority that municipalities or counties have to raise revenue in the aggregate.

C. REDUCTION OF STATE TAX SHARED WITH COUNTIES AND MUNICIPALITIES:

This bill does not reduce any state tax shared with counties or municipalities.

V. COMMENTS:

In <u>Chicone v. State</u>, 684 So.2d 736 (Fla. 1996), the defendant was charged with possession of cocaine and claimed that he had been unaware that the substance he possessed was cocaine. The possession statute provides that it is unlawful for any person to be in actual or constructive possession of a controlled substance. The Florida Supreme Court held that the State was required to prove that the defendant knew of the illicit nature of the items in his possession. Further, in <u>Jenkins v. State</u>, 694 So.2d 78 (Fla. 1st DCA 1997), the First District Court of Appeal ruled that guilty knowledge is an essential element of the offense of sale of cocaine. Thus, in order to convict a person under the sections created by this bill, the State will likely have to prove that the person who bought or sold the dog or cat fur or pelt did so with knowledge that the fur or pelt was cat or dog and not another animal.

VI. AMENDMENTS OR COMMITTEE SUBSTITUTE CHANGES:

Five amendments were introduced at the meeting of the Committee on Agriculture on March 17, 1999. All five amendments were subsequently adopted.

The first amendment amends the section of the bill which prohibits the sale of garments containing dog or cat for to provide that any law enforcement officer or humane officer rather than the Department of Agriculture may institute proceedings to enforce compliance.

The second and third amendments removes the language providing that it is unlawful for any person to engage in the business of a dealer or a buyer in pelts or furs and the language providing that no common carrier shall knowingly ship or transport any dog or cat pelts from Chapter 372 and places it in Chapter 828.

Amendments 4 and 5 remove the section of the bill which prohibits the sale of garments or items of clothing containing dog or cat fur from Chapter 501 and places it in Chapter 828.
